Special Resolutions Voted on at the AGM

There were three proposed alterations to the RFPA Constitution by way of Special Resolution.

Special Resolution 1: (Treasurer Bruce HOWE) ‘that the Committee seek to amend the RFPA Constitution at the 2025 Annual General Meeting by adding the following words - “4.8 Any applicant for membership who has been convicted of a serious indictable offence as described by the Crimes Act1900 (NSW) shall not be admitted to membership”

Resolution Voted on a show of hands and **CARRIED**

Special Resolution 2: (Treasurer Bruce HOWE) “that the Committee seek to amend the RFPA Constitution at the 2025 Annual General Meeting by amending clause 4.5 to read”

“(c) is expelled from the Association

(d) fails to pay the annual membership fee as required by Part 5, or

(e) is convicted of a serious indictable offence as defined by the Crimes Act 1900 (NSW)”

Resolution Voted on a show of hands and **CARRIED**

Special Resolution 3: (Treasurer Bruce HOWE) ‘that the Committee seek to amend the RFPA Constitution at the 2025 Annual General Meeting by amending clause 18.2 , substituting “Chair” for “President” wherever occurring”.

This Special Resolution was withdrawn by Bruce HOWE.
