Vale John Arthur Gordon Tripp – 13th June, 2025.

It is with much sadness that we must report the passing of another senior Member of our Branch, John Tripp, who left us on 13th June, 2025, at 85 years of age. His date of birth was 22nd December, 1939. His funeral service was conducted at Palmdale Gardens on 29th June, 2025.

John joined the NSW Police Force on 28th October, 1963, and became registered No. 10836. Following General Duties at Parramatta, (No. 18 Division), and then at Regent Street, (No. 2 Division), he was transferred to Wallsend Police Station where he commenced Criminal Investigation duties on 29th January, 1968, and was promoted to Detective Constable 1st Class on 29th January, 1971. He continued with Criminal Investigation duties, at Newcastle Police Station, (8th October, 1973), Mayfield Police Station, (9th March, 1977), then Chatswood, (17th September, 1979), Gosford, (23rd November, 1980), Eastwood, (9th May, 1982), and Wyong, (24th April, 1983). He was promoted to the rank of Detective Senior Sergeant on 10th September, 1987, and retained that rank until his retirement on 22nd July, 1995, at

which time he was engaged, from 12th March, 1995, on investigation duties with North Region Internal Affairs.

During his service and subsequent to his retirement, John received a number of awards: National Medal (23rd December, 1980); 1st Clasp to the National Medal,(28th October,1988); NSW Police Medal awarded with 4th Clasp, (2nd June, 2008); National Police Service Medal, (27th July, 2017);

In May, 1961, John married Margaret Winney, the daughter of Jack Winney, a former Inspector at Newcastle. They had three children: Steven, Louise and Rodney, and now seven grandchildren. Following John's retirement, Margaret and he purchased several caravans at different times, and went travelling in Australia, the United States, Canada, New Zealand and Thailand over a period of 20 years and undertook many cruises on the South Pacific. Margaret and John moved to Narara where they lived until John moved into an aged care facility in 2022. Indeed, in those retirement years they enjoyed a wonderful life of travelling and watching their family grow. The following photos illustrate the happiness they experienced post retirement.

WELFARE REPORT:

Our Welfare Officer, Barry Clark, presented details to the Meeting of those Members Not doing so well. Barry reported on Trevor Carroll who has suffered severe throat cancer. He said that Trevor now has to take food through a tube inserted into his stomach. Should he take food in his mouth it goes straight into his lungs. Barry said that Trevor can speak quite well now and hopes to attend some future Meetings but must be fed by the tube for the rest of his life.

Barry said that Bill Ide, now living in a retirement village at Umina, is doing as well as can be expected and is happy in his present location.

Social Club.

Russ Whitcher told the Meeting that the mixed lunch, to be held on Wednesday, 27th August, 2025, will be conducted at the Bateau Bay Hotel, where significant renovations have been carried out. Russ said that he has made reservations for 40 to 50 persons and our table has been arranged near a huge TV screen. The booking has been made for 11.30 a.m.

Russ said that the pre-Christmas mixed lunch will be held at the Royal Hotel, Wyong, on Wednesday, 26th November, 2025, commencing at 11.30 a.m.

Ray Hatcher said that he has recently taken a bus trip to the new Badgery's Creek airport but found the experience somewhat disappointing, principally because the information centre was on a low hill a long way from the airport, a pre-packed salad lunch was frozen, coffee was prepared from tank water taken from under the bus and, after tasting it, he tipped it out. General Business:

Chairman Geoff said that he had attended the AGM of the Retired and Former Police Association a couple of weeks earlier. He said that a copy of the financial statement of the State Branch was available for Members to inspect if so desired.

Geoff also related a story involving his attendance at the funeral of James Stewart Rutherford, OAM, father of our colleague, John Rutherford, held at All Saints Anglican Church on 10th July, 2025. Geoff said that, after the service he was approached by a very small man who showed interest in the RFPA badge on his coat pocket, wanting to know what it represented. The man demonstrating this interest was, in fact, the former Prime Minister John Howard.

Geoff told the Meeting that Members have been invited to the celebration of Retired Police Day to be held at the Wyong Police Station on Thursday, 4th September, 2025, with light refreshments served after the service. Geoff said that one of the features at the Station is a collage of photos, extending across an entire wall and embracing hundreds of photos covering much of the early days of policing in the region.

Brian McVicar drew attention to how far registered numbers in the Police Force have advanced in recent times. Chairman Geoff said that he has been advised that numbers from 6,500 to 7,000 have been reserved for applicants likely to come from Queensland or New Zealand.

John Nicholas told the Meeting of a recent event in which two of his sons competed in a car race with his younger son coming within less than half a car's length of defeating his brother, Peter, whom we know as a Highway Patrol Police officer..

John also mentioned a news feature relating to the matter of some 500 new settlers coming in every day, a situation which is leading to the thinning of Police ranks, with the present situation meaning those ranks are almost 7,000 short. Chairman Geoff said that we do not have the infrastructure to support these settlers who are being given benefits not given to our own people.

Bede Irvine thanked Brian McVicar for providing rissoles at the last sausage sizzle but felt it was a shame he had not been there to supervise the cooking process – or to provide instruction on the best way to cook them. It will be understood that not all tastes can be satisfied but, as photographs later in the Newsletter will show, there were those who enjoyed the outcome.

Chairman Geoff told the Meeting of the recent death of a retired Police Officer, William Low, who passed away in the previous week just short of 80 year of age. William was known to various Members at the Meeting.

Phil Stubbs-Mills told the Meeting of a recent experience in which he had travelled to Western Australia to stay with a niece. On his way back he stayed overnight at a caravan park, on a main road. On waking the next morning he could not find his mobile phone and then found that he had been robbed of his phone and wallet containing all his personal and credit cards. He then had to contact Qantas to get details of his flight and tracking number for his return flight to NSW. Subsequently he had to contact all suppliers of his credit cards, to have them replaced, and he complimented American Express who replaced his card in one day where others took a week or more for the same process. Phil said that, as a result of his experience, he well understands the feelings of victims of crime.


The raffle was won by Keith Hockley who donated the prize back.


John Roger and Peter Caddy are seen here in serious discussion concerning the cooking process and how it would best be approached.
